- Must have good counselling skills.
- People development skills: facilitation skills to build the capacities of children and youth.
- Fluency in English and at least two local languages.

Business Development Officer

The Business Development Officer will be responsible for the day-to-day implementation and follow-up of all income generating related activities within the *Community Strengthening Through Green Economy and Education (CSGEE)* project. S/he will be responsible to analyse the market and support the family and youth business development planning process.
